## Arena Fund - Re-Appropriating Remaining Funds

#### **CAPTION:**

Motion approving the re-appropriation and expenditure not to exceed \$95,000 for the purchase of a Zamboni ice resurfacer for the American Bank Center Arena.

### **PURPOSE:**

The purpose of this item is to approve the re-appropriation of \$95,000 from the \$1,317,915.50 remaining in the Visitor's Facility Fund to purchase a new Zamboni ice resurfacer for the American Bank Center Arena.

### **BACKGROUND AND FINDINGS:**

At the May 15, 2017 the Board ratified the substitution of the \$1.5 million one-time expense for purchase of an ice skid to a \$182,084.50 rental of an ice skid. The remaining \$1,317,915.50 was to be transferred back to the Arena Fund in fiscal year 2018.

During a recent capital projects budget reconciliation, staff learned that there were insufficient funds for the planned purchase of a Zamboni ice resurfacer in fiscal year 2017. SMG/American Bank Center is requesting that \$95,000 of the \$1,317,915.50 be reappropriated for the purchase of a Zamboni ice resurfacer for the American Bank Center Arena and the new remaining balance of \$1,222,915.50 be transferred back to the Arena Fund in fiscal year 2018.
