Approval & Recommendation of Fiscal Year 2018 Seawall Capital Improvement Program Budget

CAPTION:

Motion to approve the Fiscal Year 2018 Seawall Capital Improvement Program Budget, appropriate funds and recommend City Council approval and appropriation of funds in the amount of \$9,300,000.

PURPOSE:

To approve the Fiscal Year 2018 Seawall Capital Improvement Program budget, appropriate Type A fund balance and recommend the City Council also approve and appropriate funds in the amount of \$9,300,000 for the Seawall Capital Improvement Program Budget for Fiscal Year 2018 as shown in Attachment A.

BACKGROUND AND FINDINGS:

Projects identified for inclusion in the Seawall Capital Improvement Program have been previously approved by the Type A Board, are an expansion of a project previously approved by Type A Board, or are part of the seawall flood protection system and are eligible for use of Type A funds. Projects are listed in order of priority, with consideration given for public health and safety, protection of public and private investment, and long term sustainability of the area.
