Phase 1 Repair and Rehab

To bring the Ritz into compliance will all required building ordinances in order to ensure the comfort and safety of the patrons. **Exterior:**

- **Roof:** Roof to be repaired to extend life of current installation
- Signage: "Ritz" sign to be restored/replaced
- Side Wall mural to be commissioned and executed
- Store Front and front exterior to by restored/replace/painted Interior:
 - HVAC to be replaced
 - Fire Safety provisions as required by code
 - Seats to cleaned and reupholstered
 - **Plumbing** to be replaced and restrooms restored to code/compliant functionality
 - Electrical/lighting to be completed and replaced as needed
 - Lobby to be rehabilitated to serve refreshments /tickets etc.

The first priority will be to ensure needed standards are met in order to secure a certificate of occupancy and to place the theatre in service. *A compete historic rehabilitation is planned as Phase 3.*





Phase 2 Programs/Activities

"Initially the theatre programing as a music venue will generate the cash flow needed to cover operations expenses. Later CC Patch intends to add additional programming guided by a programming director and additional staff.

Artist Nurturing Program and Artist Collective

The Corpus Christi CVB, Governor's office, Todd Hunter, CC PATCH and Latin Grammy nominated artist Dusty Oliviera, along with many other stakeholders are currently working on creating a **Corpus Christi Music Office**. As part of this endeavor, CC PATCH is implementing an **Artist Nurturing Program** to help with the process and costs in the professional artist development process. Along these same lines, CC PATCH has created an **Artist Collective**, bringing smaller organizations under one non-profit umbrella to pool our resources for a better chance of success. The first two groups under the Artist Collective are CC Songwriters and Chica's Rock.

Broadcast Show


