Amending Ordinance 031525 Regarding Conveyance of Parker Pool to Nueces County

CAPTION:

Ordinance amending Ordinance 031525 regarding conveyance of Parker Pool property located at 654 Graham Road to Nueces County and authorizing Agreement for Payment for Utilities.

PURPOSE:

To amend the original Ordinance 031525 regarding conveyance of Parker Pool to Nueces County and authorizing an agreement for the payment of utilities.

BACKGROUND AND FINDINGS:

On August 28, 2018, the City Council authorized the conveyance of Parker Pool Property, located at 654 Graham Road, to Nueces County via Ordinance 031525. The property was defined as "approximately 0.63 acreage of land located at or near 654 Graham Road including the following improvements: the swimming facility known as "Parker Pool" including adjoining restroom facilities and adjacent parking".

Ordinance 031525 will be modified to amend the definition of the "Parker Pool Property" to be "approximately 0.46 acreage of land located at or near 654 Graham Road including the following improvements: the swimming facility known as "Parker Pool" and including adjoining restroom facilities".

This ordinance includes an agreement, Exhibit B, by which the City agrees to pay up to \$10,000 per fiscal year for the electricity, water and wastewater at the Parker Pool Property for 25 years as long as Nueces County continues to operate and provide for operation of the Parker Pool Property as a public swimming pool with general public swim program open to the public for a minimum of 20 hours per week, weather and conditions permitting. The City agrees to appropriate the funds for each year it appropriates funds for provisions of aquatics to it citizens. The obligation shall expire the earlier of the County's termination of the Agreement or 25 years from the effective date of the agreement. The Agreement also allows users of the Parker Pool Property the use of the City parking lot adjacent to the Parker Pool Property.
