5) Property Management & Development	Assisted 5 downtown businesses in the permitting process. Working with the RITZ Theatre and Texas Historical Commission on TSI Feasibility Study. Expected completion is end of June or early July 2019.
6) Streetscape and Safety Program	House of Rock has completed their project and has submitted their reimbursement request (pending approval). Shook Enterprises has requested a 2 nd extension due to contractor delays. One Streetscape Application has been submitted but major revisions are needed. Currently working with developer on application details.
7) Other Programs & Initiatives	Tenant Finish Out Program: Working on 1 application for a hair salon. Applicant is waiting for current tenant to vacate for access to space to get construction bids. Working with 3 potential applicants for the Off-Street Parking Program.
