## Corpus Christi Business and Job Development Corporation Investment Policy and Investment Strategy

### **CAPTION:**

Resolution approving the Corpus Christi Business and Job Development Corporation's Investment Policy and Investment Strategy.

### **PURPOSE:**

Each governing body of a nonprofit corporation acting on behalf of a local government or a state agency may purchase, sell, and invest its funds and funds under its control in investments authorized by the Public Funds Investment Act (PFIA) and in compliance with the investment policy approved by the governing body. The Corpus Christi Business and Job Development Corporation must adopt an Investment Policy and Investment Strategy on an annual basis as per the PFIA.

#### **BACKGROUND AND FINDINGS:**

The Corpus Christi Business and Job Development Corporation has never adopted an Investment Policy and Investment Strategy. The Corpus Christi Business and Job Development Corporation's funds have been pooled with the City of Corpus Christi's funds and invested likewise.

Moving forward, the investments of the Corpus Christi Business and Job Development Corporation will be separated from the City's investments and invested in the name of the Corpus Christi Business and Job Development Corporation. Funds will be invested in investments authorized by the PFIA and in compliance with the Corpus Christi Business and Job Development Corporation's Investment Policy and Investment Strategy.
