City Auditor's Office FY2021 Proposed Budget with Decision Packages

**<u>CAPTION</u>**: Motion to accept the City Auditor's Office FY2021 proposed budget with decision packages and direct staff to include as approved by the Audit Committee in the City-wide FY2021 proposed budget.

**<u>PURPOSE</u>**: Review and approve the City Auditor's Office FY2021 proposed budget with decision packages as recommended.

**BACKGROUND AND FINDINGS:** For FY2021, City Auditor is proposing a total budget of \$567,495. Included in this proposal is \$4,000 for required Generally Accepted Government Auditing Standards peer review and the addition of \$97,785 for two staff members (for six months of fiscal year). This proposed budget represents an increase of \$94,946 over FY2020 adopted budget.

<u>ALTERNATIVES</u>: The Audit Committee may reject all or part of the budget proposal and may suggest other changes to the FY2021 Budget.
