The commission shall be composed with 9 Adult Members and 6 Youth Members as follows: 8 Adult members; membership in one or more of the following categories is preferred but not required: (1) - Health and Human Services, (1) - Law Enforcement, (1) - Education, (1) - Youth and Family Services, (1) - District Attorney's Office, (3) -At-Large members, and (1) Faith-based organization. 6 Youth members as follows: (1) high school student from Corpus Christi Independent School District, (1) high school student from Calallen Independent School District, (1) high school student from Flour Bluff Independent School District, (1) high school student from School District, (1) high school student from Flour Bluff Independent School District, (1) high school student from a charter school. The youth members shall be high school juniors or seniors at time of appointment. Members shall serve three-year terms except the youth members shall serve one-year terms. Any vacancy shall be filled for the unexpired term. The commission shall elect a chairperson and such officers as it deems necessary. Officers shall serve one-year terms.

Most importantly, the committee will give me the power to have something that those discrimination victims lack: a voice.
