Voted a new chair from Visit Corpus Christi, discussed joint resolution and voted in support of it, recognized the work by Kevin and all of his hard work and great communication, had quick report from Nueces County Beach Management Advisory Committee, discussed permeable concrete in new construction to prevent runoff and the costs of such, also Darren reported that there was a lot of coastal erosion lately from storms, lifeguard platforms very close to the water and slightly askew, they will be moving them, still working on Packery overlook (picnic tables and benches, sign on Zahn Rd. for Packery Channel), discussed lifeguards, want to establish a threshold so that lifeguards are protected in dangerous conditions (hurricanes, etc.), will talk to Galveston and South Padre about their policies. Subcommittee working on monitoring for the Packery Channel but nothing to report yet.
