increase and in fact, proposed values have actually decreased intermittently over this same time period (last decrease was 2018). The proposed/estimated improvements value went from \$163700 in 2019 to over \$170,600 for 2020. The assessed value INCREASED from \$192500 in 2019 to over \$199,400.
I presume this to be a similar jump/rise for other residents who are also stretched thin with families, expenses, and I am seriously close to moving my family of 6 out of Nueces County. Every year I have to fight the city from being forced out of living in Corpus. This jump in "presumed" improvement and assessed value is without any quantitative or qualitative evidence and I'd like to know if the city officials are being held accountable for their tax revenues and if so, how can they justify this rare sharp increase in the face and wake of an international pandemic.
