**3.** <u>24-0232</u> Possible Ordinance Regarding Prohibition of Smoking/Tobacco Products in Certain Outdoor Areas

Staff updated the Committee that this item has been withdrawn from a future City Council agenda for their consideration as Council/City Leadership feels that broader community support is needed for a successful adoption. Staff ask for PRAC's assistance in fostering broader community support, whether it be through the school district or health professionals. Chair Lindsey requested to put this topic on the next agenda for further discussion. No action was taken.

#### 4. <u>24-0207</u> Adopt-A-Park Applications

Chair Lindsey distributed a document which explained the proposed application process to adopt a park that involves three separate tiers with specific directions/tasks. The tiers advance with responsibility with Tier 3 being the most involved. The subcommittee has been working to streamline this process and to also make the application available to be submitted online. The goal in improving the application process was to give a concise understanding of the responsibilities in adopting a park so that people would be highly interested in participating. No action was taken.

## 5. <u>24-0244</u> Bird City Texas Program

PRAC member, Joan Adams-Wolfe gave information on the application process which involves rigorous requirements for certification. She presented a brief informational video from the Texas Parks & Wildlife regarding Bird City Texas. She expressed how becoming a Bird City can be beneficial, particularly through tourism since Corpus Christi is a coast community with migratory birds. The certification process involves partnerships with several organizations, non-profit businesses and local institutions. To bring awareness of Bird City, she said the next step would be to bring organizations together to discuss involvement. Chair Lindsey suggested creating a possible subcommittee for this effort. No action was taken but it was specified to have this topic on the next agenda.














**PStationary Mobile Unit**

## Sec. 36-15. Prohibition of smoking/tobacco products in certain outdoor areas.

- (1) For purposes of this section only, the term "tobacco products" means any product that is made from or derived from tobacco, and is intended for human consumption or is likely to be consumed, whether smoked, heated, chewed, absorbed, dissolved, inhaled, or ingested by any other means, including, but not limited to, a cigarette, a cigar, pipe tobacco, chewing tobacco, snuff, snus, or an electronic smoking device or liquids used in electronic smoking devices.
- (2) It shall be an offense to consume any tobacco products in the following places:
  - (a) In all public parks, including but not limited to, public recreation fields, pools, children's playground equipment, concession stands, and restrooms.
  - (b) Within the public right-of-way and any seating located within the public right-of-way or on other city-owned property along the entire parade route of the Buc Days Parade for a period beginning two (2) hours before the start of each parade until one hour after the conclusion of each parade.
- (3) The Parks and Recreation Department, or its successor departments, shall have the authority to designate temporary smoking areas for certain special events by request as deemed appropriate.
- (4) This prohibitions under the Section will not apply to private property, the Lozano Golf Center, Oso Beach Municipal Golf Course, and all City-owned beaches.
